**'Anders Breivik has shuffled the cards. You have to start again'**

(The quiet revolution' Dutch writer Gerrit Komrij NRC 28/7/11)

Dear Mr. Thorbjørn Jagland

With reference to your answer on my letter of 2<sup>nd</sup> February 2011, regarding the abolishment of the actio popularis (See jurisprudence of the Court of the European Human Rights, case 3636/09 of the 16<sup>th</sup> of November 2010), I will draw your attention to the following facts:

Following the international news, we learnt that the internal hate of Anders Breivik was aimed to the elite. As we understand well, this massacre has taken place to young people who were educated in becoming the new leaders of this world. See the theme of the World Humanist Congress held from the 12<sup>th</sup> until the 14<sup>th</sup> of august 2011 in Oslo.

**'Most diverse Humanist Congress ever, will train the next generation of leaders'**

This hate to the elite is not exclusively dedicated to Anders Breivik. This can also be observed in the Netherlands as well as in many other countries. The attack on Queen Beatrix makes it exemplarily. For example: The show trial of Erwin Lensink (published by Pro Republica *cum suis*) and Karsten T. in Apeldoorn. Separately of these examples can also been mentioned the show trial of Geert Wilders, regarding the freedom of speech about the Islam. He has got a political association for freedom (PVV) without members. Which is allowed by Queen Beatrix?

The reason for all this hate might be found by the inferior standard of the democratic values, like freedom of speech, without any respect for the criterions of the principles of the fundamental rights, which were successfully acquired by the European proletariat in 1789 and 1848. The complete change of these attainments silently resulted in the Real policy in 1853<sup>1</sup>, which still exists. A policy without moral, ethic and values, is only possible by the effects of the saying "**He who pays the piper calls the tune**".

The massacre, caused by Anders Breivik must be a warning for the Heads of State to meditate very seriously about the basic criterions of democracy.

You, as chairman of the Heads of State in Straatsburg, should take your responsibility and initiative in putting this subject on the agenda as soon as possible in which the main item should be: Giving back to the people the knowledge of the criterions of democracy, i.e.:

- 1) The knowledge of the Volonté Générale of Rousseau (Human Rights of 1789).
- 2) The knowledge of the Intérêt Général' of Helvetius (1789).
- 3) The knowledge of the Actio Popularis.
- 4) The knowledge of the principle of the right of Nemo Tenetur.
- 5) The knowledge of the Trias Politica (Montesquieu).
- 6) The knowledge of the Code de Bordeaux (1954).
- 7) The knowledge of the very essence of informed consent.
- 8) The knowledge of the very essence of Populism.
- 9) And above all: The knowledge of the duties of the Heads of State in maintaining the principles of the Fundamental Rights of 1848<sup>2</sup>.

Right, including human rights, without duties of the Heads of State, doesn't exist! This includes the private Court of Human Rights of the Heads of State in Strasbourg as well. Through the 'Real Policy' of 1853 all the fundamental criterions of democracy, freedom and freedom of speech with political authority in the public area of the institutions have silently been abolished, provably by jurisprudence.

For example: the jurisprudence of the European Court for Human Rights 2010, case number 3636/09' regarding the abolishment of the actio popularis, mentioned in the entry of this letter.

Moreover, we demand a parliament of real representatives of the people, instead of representatives of political parties. (Examples: The Thinkers Club: German: Der Denker-Club and the board of Advisory of EKO in the Netherlands)

Therefore, the present- and new leaders, men and women, should definitively abolish the "Real policy" of 1853 including the strategy of the codex alimentarius of 2008-2013, the tetras politica and the digital mouse-click democracy like signing petitions without political authority!

Leaders should also respect the human moral, ideals, ethic and values in accordance to: la volonté générale, l'intérêt général (1789) and the principles of the fundamental rights of 1848, because: "*Only those who know the past have got a future.*" Wilhelm von Humboldt (1767–1835), German Humanist philosopher and statesman

In essence it means that all arguments, all facts, all figures and all expectations of new laws,

law changing, wars and other political questions have to be put on the table. **Germany:** *'Demokratischen Experiments Stuttgart 21, Zitat: 'Alle Argumente, alle Fakten alle Zahlen und Einschätzungen müssen auf den Tisch' Ende Zitat.* Dr. Heiner Geif3ler (Süddeutsche Zeitung 7/10 und 13/10/10).

In getting all these arguments, facts, figures and expectations of the members of the institutions on the table, will only be possible when the Council of Europe in Straatsburg as well as our Queen Beatrix respects the right of assembly of the members of the institutions with political authority, regarding informed consent.

Mentioning specifically: Only our Queen Beatrix and her family does not taste the difference between organic vegetables and genetic manipulated vegetables. Our Crown prince Alexander declared that their vegetables come from their own garden and that gave the family a good feeling. This must be the reason that freedom of assembly with political authority in the institute EKO/SKAL had been silently abolished on the 1<sup>st</sup> of January 2002.

A crucial duty of right of the legal citizenship 'actio popularis' had been changed in 2005 into the French legal maxim 'pas d'intérêt, pas d'action' (Thom de Graaf/D66). In contrast with these kind of thoughts, the world famous Dutch philosopher Benedictus (Baruch) de Spinoza said about the 'highest good' (Summum bonum) in the intellectual love of God (amor Dei intellectualis), quote: *'The greatest good is the knowledge of the union, which the mind has got with the whole of nature.*

Sooner or later, people will realize that genetic manipulation will modify the whole biodiversity. It means at the end that we will lose all our knowledge about biodiversity. In other words: we will lose our relation to God, that means the God in contact of nature. (Ibn Tufail: author of the philosophical novel, Hayy ibn Yaqdhan.)
