Free trade with U.S.? Europeans balks at lack of morals in TTIP

Dear Mr. Daniel Hamilton Esq.,

The "fundamental problem" of your discourse: "The Geopolitics of TTIP Repositioning the Transatlantic Relationship for a Changing World" is the lack of morals. The goal of TTIP is to change the world by the privatization of the natural biodiversity through the patents of the pseudoscience "GENOMICS", protected by the Codex Alimentarius of the United Nation.

This change has been already announced by the former Dutch Queen Beatrix in her Christmas speech of the year 1992, after the United Nations Conference on Environment and Development (UNCED), also known as the Rio Summit, of 1992. **Quote:** "We should find the transition to a society with a new sense of norms and rules that are commonly held on to" **Unquote** (Norms means obligation; rules mean values).

GENOMICS generates only exclusive profits for the anonymous huge shareholders of the multinationals and hedge funds. That means for the very rich. They get more money and more power. They are the new masters over the new knowledge of the new artificial biodiversity through the technique of genomics.

It means a new absolutism, the worst in human existence and history. It means an serious attempt to deduce the knowledge of the parts from that of the whole through Genetic technique, Cisgene technique, Nanotechnique and Andragogy, for the sake of privatization of natural biodiversity including human beings' organs and behaviour (andragogy): "Intimate technology - The battle for our body and behaviour" (Andragogy) by Rathenau Institute –Netherlands by "Science without borders -Holland".

The European Court of Justice **(ECJ)** opens door, without any respect for "**sovereignity of the people"**, to some **stem cell patents**" Reuters 18th December 2014. With other words this change is not related to the law or man as nature. It means there is something wrong in our relationship between high nobility (Council of Europe), the elites, the officials, the military, justice and reality.

You mentioned not a single word what people and the taxpayer think of this change. With other words, between the ideas of **TTIP** and the people there is a gap. There is no relation anymore to the historical genetic determined reality of the criterions of democracy of the modern regarding the understanding "**sovereignity of the people**" enforced during the European Revolution of the years 1789 and 1848.

For the people, that makes **TTIP** to "unnatural liberty". The fundamental understanding **"sovereignity of the people"** of the year 1848, invented by Jean Jacques Rousseau, for freedom of association for opinion-forming processes, is the main criteria to be followed when framing laws, law changing, war decisions, and other political questions and was a real contract between the people and its chiefs. Nowadays the understanding of "chiefs" is the 47 Heads of State represented in the Council of Europe in Strasbourg, with Secretary General Mr. Thorbjørn Jagland, as keynote speaker.

Rousseau's consensprincipe the idea of the general will of reason (la volonté générale) is equal to the own will of "agreements on informed consens for responsibility", the supreme control of the "common will". The consensprincipe of the idea of the general will (la volonté générale) was also a real contract between the people and its chiefs. It was with broad consensus obtained in the first Human Rights of the modern of 1789 under article 6.

It now seems that the **"high nobility"**, represented in the council of Europe, for the third time will terminate the contract with the people secretly. It means the people have to deal again with the problem of immorality. Freedom without moral freedom is impossible. That is the reason that **TTIP** is not in the hearts of the European men.

The historical genes of history of the volonté générale - you will find them in understanding "mens una" by Spinoza. It means "one mind", similar to the understanding "consens", similar to "reason". Rousseau wrote, Quote: I am in search of the right and of reason, and I do not argue about facts" Unquote. This as Rousseau said is a "regulative idea", that means in my opinion a "realpolitik of reason", instead of the immoral Realpolitik of populism of the modern of the year 1853, the mirror of the understanding "Capitalism", as it has been invented by August Ludwig von Rochau.



The idea of the volonté générale is protecting our collective values, the "summum bonum", the supreme instrument to control the parliaments and their lobbyists and the high nobility represented by the 47 Heads of State in the Council of Europe in Staatsburg, with key note speaker Secretary General Mr. Thorbjørn Jagland. It means the protection of "the highest good", equal to the protection of our collective values, similar for the understanding "general interest".

The problem of the nowadays "democracy", which devaluates itself in a "system crises", is, that there is no fundamental responsible informed consens about laws anymore. Moreover the Human Rights Council Advisory Committee of the United Nations abolished the institutional Human Rights of the year 1948 in the year 2011, without "sovereignty of the people" and despite the new ethic after World War II: "never war again".

To make this possible the invisible power in being, need a technique for subliminal behaviour change of society. This for many people is the unknown understanding of "andragogy" (German: Andragogik). Andragogy, mentioned the first time by Alexander Kapp (1833), renewed by Rosenstock-Huessy in the 1920s, is a behavioural change technique, organised by semantic manipulations within the semantic universe of the linear time. Therefore they use the cosmic will of populism of the modern and nowadays also populism of the second modern like Piketty, whistleblowers, websites and Fakebook & Co, in combination with subsidized populist "aesthetic experimental" technique. "The devil is in details". The details are in the andragogy".

The British thinker Bertrand Russell warned against "andragogy" in combination with GENOMICS as a big danger, already in the year 1952 in his book "The Impact of Science".³ It is synonym for the obedient, caused by education ("Wider den Gehorsam" Arno Gruen. Kapittel: Staatstheorien – Macht – Strukturen des Gehorsams/Seite 73, synonym für Andragogik).

This affects on human, Spinoza calls that man a slave who is led solely by emotion or opinion. The European individual people are afraid. Yet the "sovereignty of the people", especially the individual elderly people said very clear "NO" to TTIP, which means a very clear "NO" to the high nobility of the Council of Europe with keynote speaker Mr. Thorbjørn Jagland. Please pay attention to the fact that people in Europe don't trust any longer the parliaments, nor political parties, nor even the public intellectuals, it means the opinion makers, of the ngo's. Everybody is listening now to Immanuel Kant. He said: "Have courage to use your own understanding!"

This kind of technique by andragogy organised unnatural behaviour and obedience and made it possible that people have the capacity to do evil, if instructed, as we saw in the Holocaust and World War II. Nowadays we see more and more, that people round de clock are obedient to digital commandos including an addiction to Handys, Smartphones and Fakebook & Co, synonym for the understanding "Panopticon". That means violation of privacy, contrary to article 17 of the International Covenant on Civil and Political Rights (ICCPR).

This new unnatural behaviour, to live in a digital "Panopticon" is necessary to protect the "high nobility", elites and their officials for their evil GENOMIC patents. For this they developed the "*tetras politica*" by Richard de Mulder, Erasmus University Rotterdam (Netherland).

Another problem is the abolishing of the fundamental legal right of each man to defend the general interest as his own interest, by themselves against the state, called "actio popularis". It is the other side to the "nemo tenetur principle",* of the same medal. Nemo tenetur Principle means right and duty to silence. Actio popularis means right and duty to speak for the fundamental responsible informed consens, "sovereignty of the people" for the whole society for the general interest.

This right and duty by "actio popularis" is in the Netherlands, as an early bird country, changed into the French maxim "pas d'intérêt, pas d'action", similar to the oldest theory the Roman "interest theory" (Ulpian) and synonym to the French understanding "la volonté the tous", on 1st July 2005. The European Court of Human Right legitimized this with an abstract incomprehensible "statement" of court ruling synonym for the understanding "jurisprudence" without subject. Only "Verlinden against the Netherlands" has been mentioned. Petition: ECHR-LN1d11.0R (CD1) AVS/svl. Number 3636/09, 16th November 2010.

A society without sovereign Humans Rights and without actio popularis, without nemo tenetur and without freedom of association for opinion-forming processes, means a society without exemplary jurisprudence (Quaestio disputata by Thomas von Aquino), means a society without any "sovereignty of the people" as the situation of democracy nowadays in Europe is.

Those who speak in public or writes can be misunderstood, so I consider myself ready for more information. In the meantime, I remain yours faithfully as your servants for the general public good.


